7. East Taylor ditch. Keep on minutes. Call from Wyatt. None attended meeting but Wyatt said he represented SCID. Kyle needs help with filling out form. They want identity documents you own the land. Kyle asked for Vance to help with the document. Kyle asked if Mark Hancock has had problem with values but no one has ever complained. Mark said he couldn't cut his hay. No complaints on this ditch that was outstanding. Greg suggested upgrading pumps or electrical systems on the grant. Greg talked with Curly from Holbrook. Asked about right a ways. We have one by Shawn Hancock's place. Vance to get with Holland on Document. All neighbors will need to sign. Kyle will talk with Gus on what it takes to use easement. Need to have a decision maker when set up. Larry Hollands might help us with talking with neighbors. Jared Hatch also.

8. Creek cleaning with Excavator –Kyle wants to get south end of main street at the bear to willow cleaning done for next year in the fall. Get a small machine in there. Also clean up around Jack Standford, Rosales, Shawn Palmer's area. Kyle will find out what Bart Lee would charge with his machine to get it cleared. Might need a helper with him with that kind of machine. Prepare for next year clean up. \$50,000 available.

9. Ortega Lake Zoom Call – Call with Benny. Wants more time before deeding back. He wants to make improvements. Try and enhance Property to get higher evaluation. Talking about 7 years total. Asked about two wells being placed where we would like them or have a say in this process. We only want to maintain the head gate and be able to put water in the lake when we have big floods. Vance will get with Holland on this with legal issues. [We need a new contract made up and give 5 years.](#)

10. Darren Jensen – Wants to build a driveway over our pipe in Snowflake. Darren wants to do a low water crossing. Do 4 to 6 Colverts done. Cement. Darren will see how deep pipe is. Issued our concern that big cement trucks don't crush our Pipes. Ross also concerned about settling by the box.

11. Water Issues?

- a. GPR – Ross wants to contact the people that made it so he can get trained on how to use it. Ross is going to call the company to get some training on it. Ross called and they are supposed to call him back to set up a training. Ross is hoping to get it sold and buy a snake with a camera from Home Depot. The GPR people said that there's a guy in Texas that might want to buy it. Ross still needs to get ahold of them. Vance will work on this on 7/7/26. Ross see about the GPR this week and see if connect and work.
- b. Need to clean out the concrete things at little Mormon lake – Ross says that there is a pack rat nest inside. He says that we need to get a mini-ex up there to clear it out.
- c. Need to make/repair catwalk at little Mormon lake – Ross has measurements.
- d. Well 1 – We will just need to check on Well 1 at the end of the year. Pumps gets hot. New used pump from belly button on it. It is running really hot. Need to rebuild motor on other one. Well does not have very many openings. Finns on top are broken off. No invoice from Willis drilling.
- e. Leak on Willow Lane – There is a leak by McCleave's in the middle of the field.

- f. Kyle Baldwin – Water is coming back in the fields thru the drain. Problem was caused by SCID when we raised the dam. Ross suggested a culvert and flap. 12 inch pipe. Vance says just buy the parts, we created the problem. Kyle said he would buy the culvert. Have the 12 inch flap gate and need to get it in. [Kyle has Culvert.](#)
- g. Couple of Inline Valves -One by Don Shumway; getting hard to shut up. Already they fixed 3 inline valves this last month. Vance has one more to add; over on Vance's, upper valve. Located by Palmers. Someone ran over it 3x and needs a new stem. Let Vance know when done so he can put Rocks around it so they can't run over it again. Ross said they would try and put another T post over by Don Shumway's or a Rock. Don Shumway tomorrow and then try to get up by Vance place. Ross will check on Don 1 more time to make sure all is good. [Don Shumway doing good. - New issue Keagan Owens has broken valve in Snowflake. Try to get to it when water is out of ditch. - Smith Pasture rock in wash gone. Suggested to do Concrete and rock to fix it. - Les Johnson Flooding area no drainage area. City responsible. -Ross to fix Back hole. Note: Schoens Damm had motor taken and batteries. Nav. County to replace.](#)
